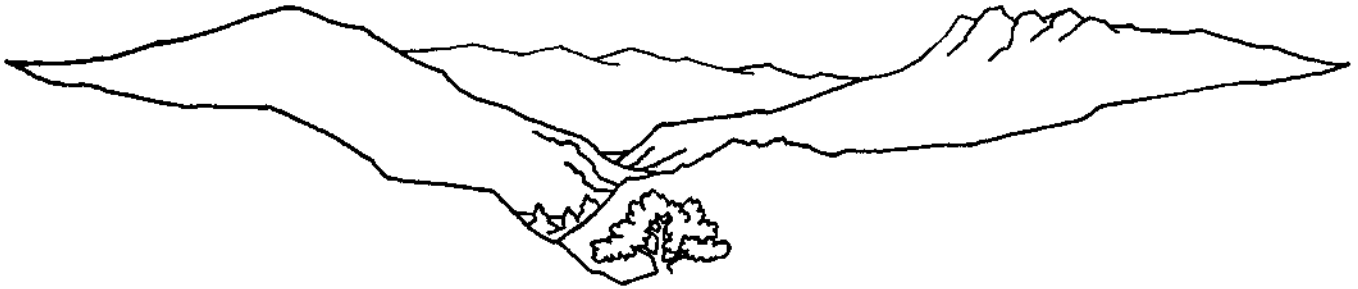

## **BACKGROUND:**

On March 14, 2007, the Board authorized Staff to initiate the annual Conejo Open Space Trails Advisory Committee (COSTAC) selection process administratively. Accordingly, Staff directed the City Clerk's office to begin the 2008 recruitment process for five COSTAC vacancies on March 4, 2008. The Vacancy Notice was posted on March 6, 2008.

Twelve applications were received during the 30-day filing period that ended on April 4, 2008. The applicants were interviewed between April 24<sup>th</sup> to May 6<sup>th</sup> by COSCA Associate Planner Shelly Austin, Supervising COSCA Supervising Ranger Glen Kinney and COSCA Manager Kristin Foord. The interview panel provided guidance to the Nomination Subcommittee, composed of COSCA Board Chair Rorie Skei, General Manager of the Conejo Recreation and Park District Jim Friedl, and COSCA Manager Kristin Foord. 


